Background

Job Training Institute Pty Ltd (the RTO) has been operating as an RTO since 2009. The RTO is a privately operated organisation that is owned collectively by the CEO together with a family trust.

The RTO is also an approved CRICOS provider (commencing 2014) to deliver training from a site located in Dandenong, Victoria.

The RTO has applied to deliver specific courses from their approved scope of registration at a new delivery site located at Level 4, 259 Collins Street, Melbourne VIC 3000, for a capacity of 800 students. The RTO would like to deliver the following qualifications at this site:

- o Certificate III in Individual Support
- o Certificate IV in Business
- o Diploma of Business
- o Advanced Diploma of Leadership and Management
- o Certificate IV in Disability

- Diploma of Early Childhood Education and Care
- o Diploma of Community Services

Subsequent to submitting their application, the RTO has agreed to reduce the maximum student capacity for the new site from 800 to 579. The RTO has also agreed to remove from its application the 2 English as an Additional Language (EAL) courses due to the changes which have occurred in that industry sector. The RTO advised that it is their intention to submit a further application to add these EAL courses as ELICOS programs in the near future.

Summary of organisation and management structure:

- The RTO is managed by a CEO with guidance from a Board of Management. The management team consists of:
 - Training manager
 - General Manager
 - Campus Managers (3)
 - Course Managers (2)
 - Human Resources Coordinator
 - Accounts Manager
 - IT Systems Manager
 - Marketing Manager

Scope of registration:

• The RTO is approved to offer 17 full qualifications, and 1 unit of competency, from within the Business Services, Community Services, and Health Training packages, together with EAL, first aid, and anaphylaxis/asthma.
